You fully indemnify and hold harmless of any wrongdoing and damages The Right to Choose Healthy Food Club, its Organizers, Members, Members Guests, Board of Directors and Member Farmers should anything arise that is or could be attributed to any of the above mentioned parties.

You understand and agree that The Right to Choose Healthy Food Club is a private, Members only organization that is not engaged in the conduct of any trade or business, commerce transactions.

**IMPORTANT PROCEDURES**

- Check** payment for foods purchased must be **provided at time of pickup**. Check to "Amos Miller". If unable, you must mail it to Donna Katona the same day you received your goods (email [Donna@RockwellNutrition.com](mailto:Donna@RockwellNutrition.com) to obtain her address).
- You must **pick up your goods within 2-3 hours** of delivery. If you cannot, you may call Esquire Express in Miami to have them delivered for apx \$20 for within Miami. **Esquire: (305) 530-9580**

- Pick up is every other Monday at 10am in Miami or Noon in Plantation. If you miss the deadline, contact us to see if Amos can still include your order.
